Police are already planning for this and we will be running pro-active policing operations focusing on road users, (traffic) as well as those that use the water, (boating). ANNUAL GENERAL MEETING OF THE REGISTER

Bellarine Community Support Register (BCSR) held its Annual General Meeting on 28 October 2021 when a new Committee was elected.

This will ensure the smooth and ongoing operations of the Register as it celebrates its 17th year of providing a free volunteer service to residents on the Bellarine Peninsula.

One service provided by the Register is our Care Calls to Registrants who request them. These calls have been particularly important during the past two years with the isolation experienced by many due to COVID lockdown restrictions and the inability to have family, friends and loved ones visit.

We acknowledged two long term Committee members – Chairperson Gail Rodgers and Jenny Gibbs who both stepped down from the Committee but will remain with the Register as volunteers.

Gail joined the Register Committee in 2007 as the Register was establishing on the Bellarine.

In 2016, Gail took on the role of Chairperson and has led the organisation through 3 strategic planning cycles as well as securing the pro-bono services of Utilitise IT in the development of a new database called Safeguard.

Also retiring from the Committee was Jenny Gibbs after a combined contribution of 12 years. Jenny has driven the distribution of brochures and presentations to community/service groups which has been most challenging in the past 12 months. Jenny's considerable commitment over her many years as an Office Volunteer, Care Caller and Committee member has been outstanding and greatly valued.

Two recognition awards for 15 years of service were awarded to Barry Collinson and Markus Stadler. Both Barry and Markus have provided incredible dedication to the organisation over this time. We thank them for their commitment and service.

Additional service awards were presented to acknowledge 5 years service to Rhonda Rotherham, Jenny Gibbs (both previously served) and Bob Jordan. Lyn Codd received a 2 year certificate.

The organisation thanks all its volunteers for their dedicated contribution to the organisation. Without their preparedness to continue the service from their own homes, using their own resources, the Register would have been forced into hibernation during the COVID pandemic.

ANN NICHOL AWARD



The Register Committee has instituted an award to acknowledge an individual/s who have made a significant contribution to the Register. It has been named the *Ann Nichol Award* in honour of the founding Chairperson of the Bellarine Community Support Register, Mrs Ann Nichol OAM.

This Award acknowledges the significant and continuing contribution over a number of years by a Volunteer (Member) in pursuit of the organisation's goals and objectives.

The announcement of the inaugural Ann Nichol Award recipient was made at the Annual General Meeting. The recipient was Mr Markus Stadler, a volunteer with the Register since 2006.

Markus has been involved in the development, programming and administration of the BilbiWare database used by our Register where residents' personal information is available to authorities in emergency situations. He has provided advice and support to the Officer in Charge of the Bellarine Police Station, training to the new Police Members and Volunteers in the use of the database.

Markus has made a significant contribution to the organisation by providing a substantial income to BCSR through the sale of BilbiWare licences to thirteen registers in the State of Victoria.

With the need for a modern equivalent of Markus' BilbiWare developed in 2006, Markus supported the investigation of a new database for the organization.

With Marckus' input, Utilitise IT is close to completing a new database package called Safeguard.

We await its arrival.

BACA DONATION

BACA was a not-for-profit, community association established to provide a voice, advocacy and support for models of service delivery and accommodation on the Bellarine.

The BCSR Committee is delighted to have received these funds which will be used to ensure our ongoing goals are achieved.

A Correction

When the Friends of Ann Nichol House group was discontinued in 2015 it was agreed that all remaining funds be transferred to the Bellarine Aged Care Association (BACA) with the proviso that they would continue to be used to support and be a voice for older Bellarine residents. Recently, due to changed circumstances, the BACA Committee decided to cease operating and to donate all remaining funds to six existing Bellarine community organisations, one of which is BCSR.

In early October 2021, along with representatives of the other community organisations, Jenny Gibbs. Volunteer and Committee Member, represented BCSR at a function to recognise and publicise the generous handing over of a total of \$36,000 to those six organisations. The function was reported in the 7 October 2021 issue of the Bellarine Times. Unfortunately, the print edition indicated that Jenny represented the 'Bellarine Parkinson Support Group' rather than the Bellarine Community Support Register, A correction was made to the on line edition but no correction was able to be inserted in the following week's print edition.

A SELECT group of community organisations are now able to give back to the community because of the dissolution of one of the region's most well-known advocacy groups. Six selected groups will share in the amount of \$15,000 after the Bellarine Aged Care Association (BACA) was dissolved due to various factors.

IN - HOME COVID 19 VACCINATIONS

The Bellarine Community Support Register has been advised that the Western Victoria Primary Health Network is supporting a number of General Practices within the Bellarine service area to complete in-home COVID-19 vaccinations for vulnerable persons within the community.

Eligibility to access this service includes, but is not limited to;

- those who are experiencing homelessness, including those living on the streets, in emergency accommodation, boarding houses or between temporary shelters;
- people with disability or are frail and cannot leave home;
- people in rural and remote areas with limited healthcare options, including those who cannot travel to a regional centre;
- culturally, ethnically and linguistically diverse people, especially asylum seekers and refugees and those in older age groups who may find it difficult to use mainstream services;
- those who are not eligible for Medicare and live in an area without access or choose not to access a state, territory or Commonwealth Vaccination Clinic;
- aged care and disability workers, with consideration to all auxiliary staff working on-site:
- · new residents relocating into aged care facilities and
- people who would have difficulty getting vaccinated for other reasons without a visit to the home (those reasons do not need to be specified).

Access to this service is simple, and as easy as contacting the general practice directly to book a home visit.
